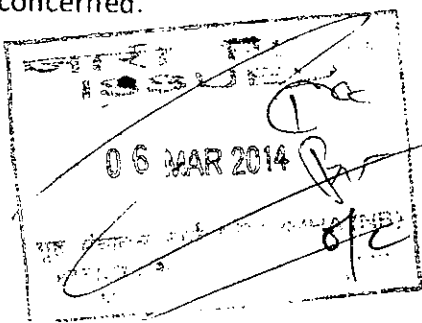

3. Kindly, therefore, treat the requisite information as NIL, as far as this Division is concerned.



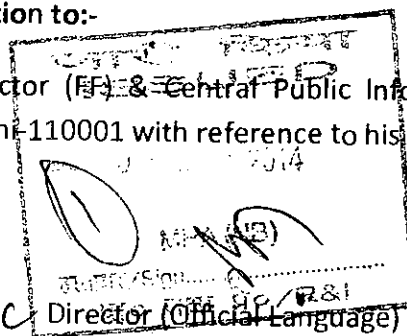
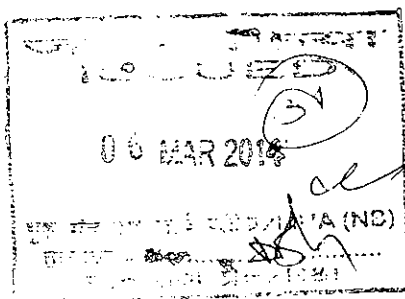
