## BETTERMENT OF SECRETARIATS

I have to advise with great pain that the Secretariats of Various Departments/ Ministries/Organisations are functioning in a miserable state of affairs and it is a hard nut to be broken to trace a grievance/petition received from public. Though the OM No.1/6/2011-IR Dated the 15th April, 2013 issued by DOPT says, "ALL GOVERNMENT OFFICERS HAVE TO FOLLOW LAID DOWN OFFICE PROCEDURE MANUAL OR THE OTHER RULES which gives details of how representations, petitions and applications from citizens must be dealt with." But hardly any Secretariat might have been functioning within the discipline fixed by the manuals and rules etc. The prescribed rules are moulded to suit the convenience to staff. I have further observed that Government has lost total control over staff, and no periodical returns to check the system are being prepared and furnished. I think the following Appendices might have been discontinued for pretty enough periods in different Secretariats:

- APPENDIX 56 Inspection Questionnaire on Organisation & Methods(O&M) prepared Vide para 135(1) of Central Secretariat Manual of Procedure
- 2. APPENDIX 57 Inspection Questionnaire for Departmental Record Room- prepared Vide para 135(2) of Central Secretariat Manual of Procedure
- 3. APPENDIX 58 Management Information System(MIS)- prepared Vide para 135(3) of Central Secretariat Manual of Procedure

Therefore please ensure that the above Appendices are prepared regularly by all Secretariats and put in public domain u/s 4 of RTI Act so that the citizens may know the efficiency of the Public Authority under watch.
