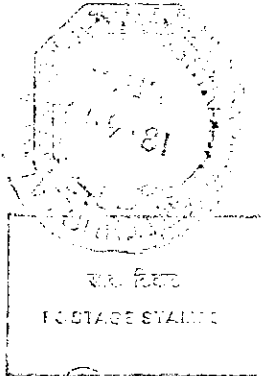

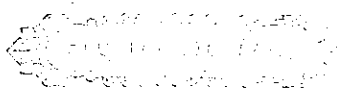

Subject: Regarding RTI application of Dr. A.P. Majeed Khan, under RTI Act, 2005.

Sir,

Please refer to your RTI application dated 18.06.2013 under RTI Act, 2005, which was received by the undersigned on 27.06.2013.

2. Para wise reply to the information sought vide letter under reference is given as under:

- i) The security clearance has not yet been granted to the proposal received from DGCA in respect of Dr. A.P. Majeed Khan for operation of Hang Guider.
- ii) The proposal was received from DGCA on 17.5.2010.
- iii) & iv) DGCA letter No.10/10/2010-AI(1) dated 29.6.2010, in original has not been received in this Ministry. The covering note was sent by DGCA vide their letter dated 2.11.11 without any enclosure of their letter dated 29.6.2010. Notwithstanding the above, action in the matter has already been initiated by MHA to process the said proposal and the same was referred to the Central Agencies by this Ministry.
- v) Keeping in view the fact that the security clearance proposals are considered in consultation with the central security/intelligence agencies which are exempted under section 24 read with second schedule of RTI Act and the file contains the inputs of these agencies, the copies of files along with notes cannot be provided under section 8(1)(a) and 8(1)(g) of RTI Act, 2005.


(ii)

The Ministry of Home Affairs has taken up the matter with Ministry of Civil Aviation to address the security concerns with regards to operation of Ultra Light Air craft, Power Hang Glider, Hot Air Balloon and sought certain information on the issue which is still awaited from Ministry of Civil Aviation. The said concerns and the possibility to address the same are in general applicable to all similar applications pending in MHA including the proposed one of Dr. A.P. Marjood Khan.

3. In case you are not satisfied with the reply, as per Section 39 (1) of Right to Information Act, 2005 you may file an appeal within 90 days from the date of receipt of the first reply to the Authority whose particulars are given below:-
