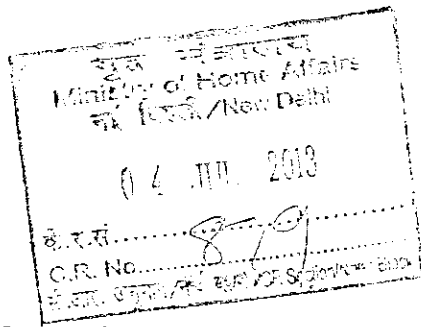


2. As far as IS-II Section of IS-I Division is concerned, the information sought by the applicant does not relate to this Division.
