3. However, the RTI application is transferred to Director (IS-II), MHA under section 6(3) of RTI Act, 2005 with the request to furnish the information to applicant directly.

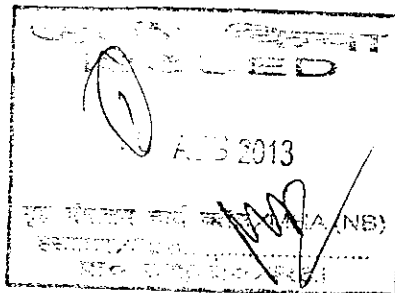
