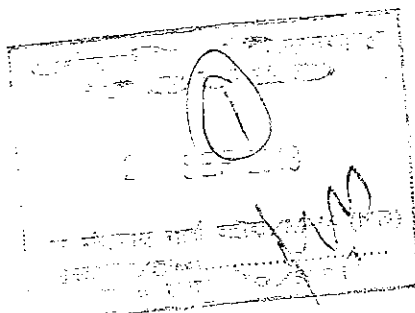
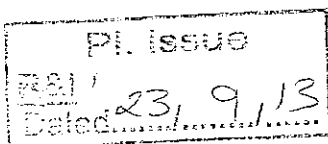

Sir,

Please refer to your RTI application dated 08.09.2013 under RTI Act, 2005, which was received by the undersigned on 13.09.2013.


2. It is informed that since the any correspondence conveying comments of this Ministry on security clearance proposals is between M/o Home Affairs & M/o Civil Aviation and is based on inputs from agencies, which are exempted from RTI Act, under Section 24 of RTI Act, the copies of documents can not be provided. The implication on eligibility for Govt. Jobs or not cannot be commented by this Section, since it is for the concerned Department/Ministry to take a decision in the matter. Since the denial of security clearance in any case is based on inputs from agencies, which are exempt from RTI Act, the grounds for denial can not be disclosed.

3. In case you are not satisfied with the reply, as per Section 19(I) of Right to Information Act, 2005 you may file an appeal within 30 days from the issue of this letter to the first Appellate Authority whose particulars are given below :-
