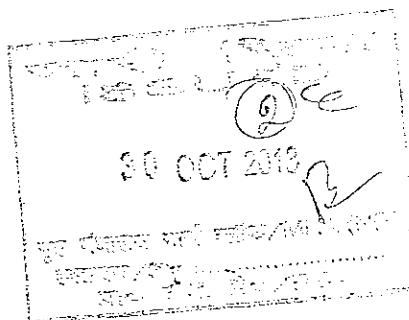
2. It is informed that the comments of this Ministry is as under:-
