2. Para wise reply of information sought is as under:

Para 1 to 3: A proposal to make it mandatory for mobile service—providers to collect fingerprint/biometric data of subscriber before activating the mobile number was received from Commissioner of Police, New Delhi. Since the issue comes within the preview of Department of Telecom, same was sent to DoT for examination at their end. MHA letter addressed to DoT is enclosed. As regards the Commissioner of Police letter and file notings, it is intimated that information relates to third party and also contains issues other than those referred in RTI application. Accordingly, response from Delhi Police has been sought in the matter. On receipt of their response, pending information will be provided.

Para 4: On the subject, one reply has been submitted by Department of Telecom in response of Lok Sabha Unstarred Question No 548 dated 07.08.2013. Copy of same is enclosed for reference purpose. Purpose of the proposal is to make mobile verification guidelines more stringent for providing new mobile connection.



- 7) A description of the existent or proposed statutory and administrative mechanisms for preventing misuse of personal data collected by the mobile service providers and maintained in the proposed central database; and
- 8) A description of the existent or proposed statutory and administrative mechanisms for data-subjects to access their personal data that will be held by the mobile service providers and the central database for the purpose of correcting any error.



Fingerprint may soon become compulsory for SIM card



The government is exploring the option of making it compulsory for telecom service providers to take fingerprint or any other bilometric feature of the subscriber when he/she applies for a new mobile connection. File photo

The government is exploring the option of making it compulsory for telecom service providers to take fingerprint or any other biometric feature of the subscriber when he/she applies for a mobile connection.

The Department of Telecom (DoT) recently received a suggestion from the Ministry of Home Affairs indicating that the DoT maintain a central database of all subscribers with bio-metric parameters akin to the Aadhaar, Minister of State for Communications and IT Milind Deora said in the Lok Sabha.

This would entail taking fingerprint/thumb impression or any other unique bio-metric feature of the subscriber when he/she applies for a mobile connection, he said adding that the suggestion "is presently being examined in the DoT and decision on the same is yet to be taken."

Last year, the DoT made it mandatory for a service provider to physically verify an applicant before issuing a SIM card. However, there have been reports that the process is not being adhered to.
