2. Para wise reply to the information sought vide letter under reference is given as under:

(i) The proposal for purchase, registration and operation of Microlight aircraft in r/o Ms Manjula Godi received from DGCA is under consideration this Ministry. There is no specified turnaround time for processing the proposals. It is informed that the Ministry of Home Affairs has taken up the matter with Ministry of Civil Aviation to address the security concerns with regards to operation of Micro Light Air craft/Power Hang Glider/Hot Air Balloon and sought certain information on the issue which is still awaited from Ministry of Civil Aviation. The said concerns and the possibility to address the same are in general, applicable to all similar applications pending in MHA.

3. In case you are not satisfied with the reply, as per Section 19 (I) of Right to Information Act, 2005 you may file an appeal within 30 days from the issue of this letter to the first Appellate Authority whose particulars are given below:-
