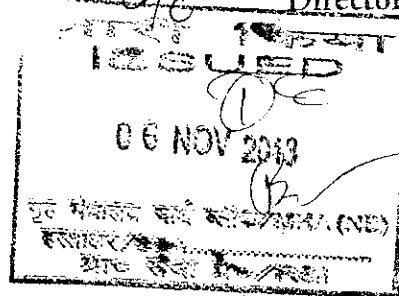
Please find enclosed an on-line RTI application dated 15.10.2013 received by the undersigned on 4.11.2013.


