On the 2007 at Charchgate suburban railway station of Mumbai, one Remote Explosive Detector whose range was 650 meter front was installed by me with co operation and help of Ex. Maharashtra Director General of police P S Pasaricha. After his retirement then Commissioner of police (Mumbai Railway) Government Railway Police (GRP) Ashok Kumar Sharma and SHO Charchgate Railway police Mr. Vasant Bagve was mysteriously removed it under instruction of then Divisional Railway Manager (DRM) Mumbai central Division Western Railway. This Detector was Designed by me and given free of cost to Government Railway Police (GRP) Maharashtra. I was loss my efforts did for human safety at crowded places like Railway stations where physically impossible to frisk every traveler and check whether anybody have any explosive. Same time Railway was fitted Air/Gas stuffed electric Balloons in the same stations. Due to risk of sudden bursting of these balloons due to rising atmospheric temperature changes and if any miscreant person fire from mob to the balloons, the risk was people will disturb thus may create stamped in the narrow station premises, and people will fell down in the track and incoming train will pass over on them. The Ex. D G Police Pasricha was removed it despite of resistant of above Railway DRM. Now on last week of October 2013 the same Balloons came back and fitted on mouth of train platforms in between one and two in same Charchgate station. According to Railway and SHO (GRP) Charchgate Railway police Station this Balloon is safe and cant burst, internal security wing Government of India has given clearance to us. They told this balloon was imported from France therefore it is safe. Now my questions are: 1. Weather any such security clearance is given by internal security wing of Home Ministry If yes please provide me copy of clearance. 2) The internal security wing of Home Ministry is having concern to public safety 3. Is Railway or Railway stations of India are free to ignore Directions given by internal security wing Ministry of Home regarding public safety 4. Railway protection Force (RPF) is Para military force working under Ministry of Railways therefore they cant go against railway officers wish or financial interests of railways. Therefore they are helpless to take any action of this risky activity of railways for collecting Advertise revenue. 5. Then who is authority to ask railway to stop this risky act playing against common citizens lives
