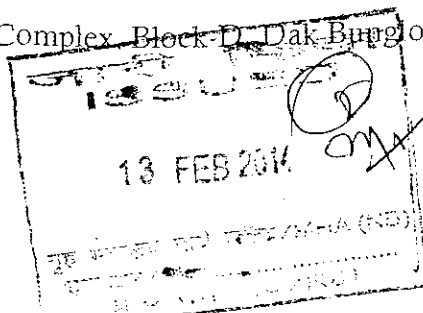

 8. Provide me the dates wise communication lists that RPO PATNA has done to my communication address.
 9. Did any authority (Police or Court) approached to RPO Patna before seizure of my passport. i.e. before 03-Jan-2014
 10. Did any authority (Police or Court) approached to RPO Patna after seizure of my passport. i.e. after 03-Jan-2014 If yes what was the source of communications to RPO Patna.
