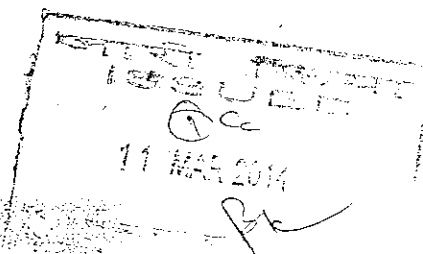
3. As regards para 4 of RTI application, you are requested to take up the matter with the specific State Governments. This office does not maintain/compile the desired information.

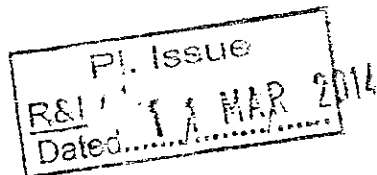
