
Sir,

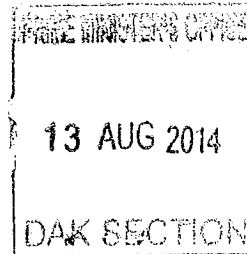
