

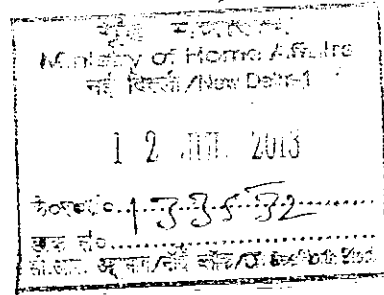

Dear Public Information Officer:

Under the Right to Information Act 2005, Section 6, please provide me the following information

- (1) Please provide me the statistical data in numbers as well as in the tabular form of the case registered under section 67 of the Information Technology Act, 2000 in all the police stations of India since 2000 against any web site and the web search engines of Google, Yahoo, youtube, Bing, Yandex, Ask and AOL for the publication of any obscene material in electronic form which is



lascivious or appeals to the prurient interest or if its effect is such as to tend to deprave and corrupt persons who are likely, having regard to all relevant circumstances, to read, see or hear the matter contained or embodied in it.

- (2) What are the specific measures taken by the Ministry of Home Affairs to restrict, prevent, and mitigate the circulation, distribution and exhibition of the obscene material since 2000 in all the web sites and the web search engines of Google, Yahoo, youtube, Bing, Yandex, Ask and AOL under sections 67 of the Information Technology Act, 2000, 292 of the Indian Penal Code or under any other act for the time being?
- (3) The list of websites banned and the reasons for ban since 2000.
- (4) The list of websites that were restricted by the Ministry of Home Affairs in the web search engines of Google, Yahoo, youtube, Bing, Yandex, Ask and AOL, which are publishing the obscene material since 2000.
- (5) The list of web material that was restricted, removed or deleted from the web sites since 2000.
- (6) The steps taken by the Ministry of Home Affairs since 2000 in India to restrict the reach or availability of adult sexual content in the web search engines of Google, Yahoo, youtube, Bing, Yandex, Ask and AOL for age group below 18 years.
- (7) The steps taken by the Ministry of Home Affairs since 2000 in India to reduce the reach or availability of extreme adult sexual content, such as rape porn, child porn, group sex porn and other unethical kinds.
- (8) The steps taken by the Ministry of Home Affairs since 2000 in India to restrict the pop-up windows which takes us to adult sexual content websites for age group below 18 years in the web search engines of Google, Yahoo, youtube, Bing, Yandex, Ask and AOL.

**Please answer the following questions:**

- (9) Is it not true that any person can access the web search engines of Google, Yahoo, youtube, Bing, Yandex, Ask and AOL irrespective of his/her age in India?
- (10) Is it not true that any person without logging with his email id can access the web search engines of Google, Yahoo, youtube, Bing, Yandex, Ask and AOL in India?
- (11) Is it not true that the web search engines of Google etc., will millions of results within split second on just typing the word "porn" in India?
- (12) Is it not true that the results appeared on typing the word porn in the web search engines of Google, shows the websites



www.youporn.com, www.redtube.com, www.porn.com along with many other sites in India?

- (13) Is it not true that the homepages of the websites www.youporn.com, www.redtube.com, www.porn.com, contain many images and videos that are lascivious and appeals to the prurient interest that tend to deprave and corrupt persons who are likely to read, see or hear the matter contained or embodied in it in India?
- (14) Is it not true that the web search engines of Google publicly exhibits, distributes and circulates obscene images on just typing the words "child nude", "child sex" and "xxx" in India?
