Please refer to your application dated 19.08.2014 under the RTI Act, 2005, which received in this office on 1.09.2014 as transferred by Under Secretary & CPIO, RTI Cell, MHA vide their letter No.43020/01/2014-RTI dated 29.08.2014. It is informed that as per available records in this Section, no official letter has been received by this Ministry from Govt. of J&K for the complete/partial revocation of the Armed Forces Special Power Act (AFSPA) in the State of J&K. However, Hon'ble Chief Minister J&K had raised the issue of phased withdrawal of AFSPA from the State during his meeting with the then Hon'ble Home Minister on 14.11.2011. During the conference of Chief Minister's on Internal Security held on 5.06.2013, Hon'ble Chief Minister, J&K raised the issue of phased withdrawal of AFSPA from the State, beginning from the areas which have been free from militancy for quite some time. It is also informed that in a meeting by the then Hon'ble Home Minister with concerned agencies held in 2013, it was advised that time is not appropriate for withdrawal of AFSPA at this stage.

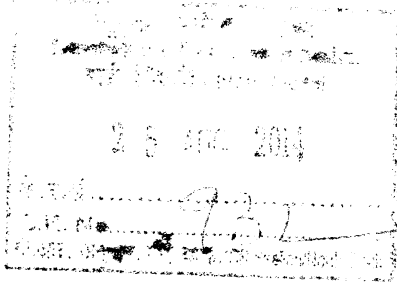
