I am directed to refer to your RTI application dated 24.03.2013 received in this Ministry on 09.04.2013 seeking information in respect of this Ministry's letter F.No. 13012/10/2012-K.VI dated 18.10.2012 which was referred to Principal Secy. (Home) regarding the suggestion to move Darbar on yearly basis.

2. In this regard, I am to state that your aforesaid proposal has not been accepted by the Government of Jammu & Kashmir on the following grounds:-

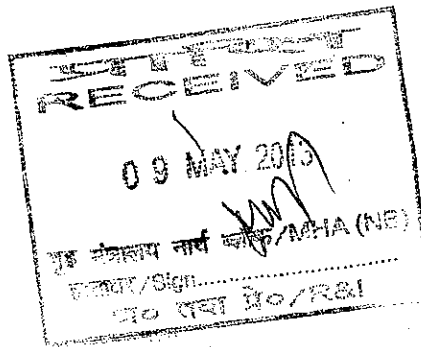
- (i) The shifting of offices from Jammu to Srinagar and from Srinagar to Jammu has been Put in place in the benefit of people of State to ensure equitable development of different regions of the State. It is only the offices which are headed by the Administrative Secretaries which shift with Darbar Move.
- (ii) This practice not only connects people of different regions of the state, but also binds different sections of the society and results in maintaining the cultural integration and secular fabric of the State.
- (iii) The basic services are delivered to the people through field officers and heads of the Departments. In almost all public utility Departments, separate heads of Departments are in positions in both divisions. This minimizes the requirements of the people from going to the Civil secretariat as major services are delivered at both the divisions.

3. Shri R.K. Srivastava, Joint Secretary (Kashmir), MHA, North Block, New Delhi is the appellate Authority in the matter.

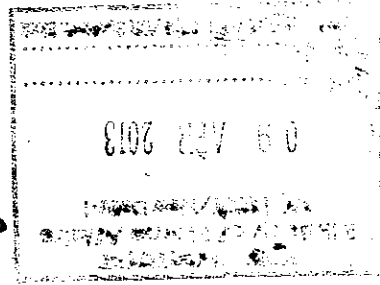


