

2. With regard to point No. 13, it is stated that there is no provision in Jammu and Kashmir Division, MHA to provide subsidy for Amarnath Yatra.



With regard to point No. 14, it is stated that the beginning and the end of the Amarnath Yatra is determined by two factors- the date on which the routes get clear of snow and the date on which the Raksha Bandhan falls. The Yatra begins on the date on which the route is clear of snow and it ends on the date of the Raksha Bandhan. The Yatra duration in a given year can longer or shorter, depending on the date on which Shravan Purnima (Raksha Bandhan) falls.

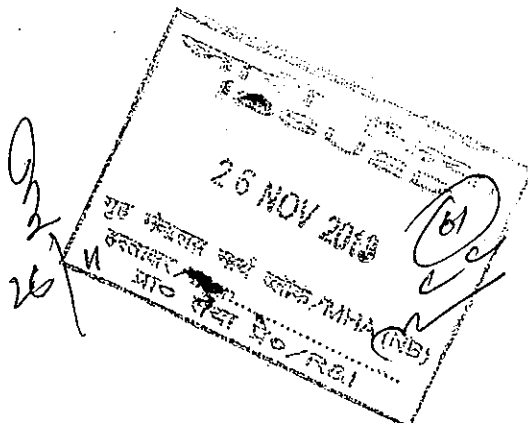


