The said letter further informed that the RTI-ACT extends to whole of India except J&K State .Here the question arise that J&K State is not a part of India?

Sir,

There is no doubt now that M.O.A (DAC) G.O.I has been giving tremendous rise to corruption practices in SFAC/MFPI and the secretary Agriculture (DAC) & MD (SFAC) & Horticultural Commissioner & Secretary (MFPI) has been playing a major & very important role in its acceleration & surprisingly, the facts has been confirmed by Director project/CPIO (SFAC) & Assistance Industrial Adviser/CPIO (MFPI) in their letters. In this connection we are submitting here as under:-

It is now proved that the MFPI has deliberately delayed the implementation of our project by projecting wrong facts and has deceived other Government Agencies (States &Central) & as such no further evidence is required in this behalf;

Regarding Information sought by us under RTI-ACT vide letter dated 3.7.2013; we didn't received any information till date.

Regarding other information sought by us under RTI-ACT informed vide letter dated: 11.7.2013 in response our letter Mr. Surinder Singh (Assistant industrial Adviser/CPIO) MFPI inform to us that MFPI already send reply vide letter dated: 28.01.2013. We haven't received said letter so far. We want MFPI, to produced postal receipt to us as evidence. MFPI has manipulation, &Direct/Appellate Authority is also involved in dirty game.

We have been informed vide letter dated; 14.8.2013 that such information cannot be provided to me as the same is commercially confidential & on its disclosure may harm the competitive position of the third party and therefore this information is exempted under section 8(1) d; & can also endanger the life or physical safety of the person to whom such information relates. (Copy enclosed-Annexure-A)

In the above matter it is informed that RTI-ACT entitles to any person (who so ever he may be) irrespective of caste, color & religion to obtain & seek any type of information relating to anybody from any department. There is no such rule that can debar anybody from obtaining any such information from any office. It is obvious that information is not provided to me as *I am the father of the Women Entrepreneurs (M/S Sultan Agro Tech (P) LTD)* of the proposed venture/ project only for one reason i.e. they will get themselves exposed of their misdeeds & wrong information given to other quarters (in our case) & also the harassment & excesses met by us (due to their lapses) which also led to non-completion of project.

It is also strange that another applicant from the State of J&K has sought same information under RTI-ACT from MFPI, & the information sought for by another applicant was provided by the MFPI vide their no; F.NO. MFPI /RTI 2006 dated 7.8.2013 & 22.08.2013. (Copy enclosed-Annexure-B)

As per letter of MFPI which reads that the RTI-ACT extends to the whole of India except state of J&K UNDER MM-IV. In other words the Ministry is telling that the J&K is no more part of India & is independent. MFPI declines the fact that J&K IS AN INTEGRAL PART OF THE COUNTRY, then in that course, why to blame terrorists who also seconds & affirms MFPI opinion & views. It means the scheme

does not fall under MM-IV in the state of J&K in view of the fact that schemes are clearly approved by you for J&K

What was the reason SFAC didn't provide information to us under RTI-ACT& has thus violated RTI norms/ regulation? They didn't provide the information to us because they were afraid they will get exposed of their misdeeds and the excesses met by us at their office .The said letter further informed that the RTI-ACT extends to whole of India except J&K State .Here the question arise that J&K State is not a part of India ?

#### Brief facts of the case:

Mr. Fayaz Ahmad, J&K sought information under RTI Act vide application dated 10.01.2013, which was received by this Ministry on 17.01.2013. He sought copies of bank sanction letter and bank appraisal note of M/s Super Star Food Products, Khunmoh, Srinagar and M/s Fruit Care Agro Industries, Pingling, Pulwama. After examining the application, CPIO passed Order dated 28.01.2013 as per the provisions of Section 11 and Section 8(1)(d) of the RTI Act 2005.

### Discussion and findings:

I have examined the matter and noted that the CPIO had issued notices to the concerned third parties i.e. M/s Super Star Food Products, Khunmoh, Srinagar and M/s Fruit Care Agro Industries, Pingling, Pulwama seeking their comments / consent on disclosure of information as per Section-11 of the RTI Act. These third parties have not given their consent / did not agree to disclose any information relating to their projects including bank term loan sanction letter and appraisal note etc., to any person. Since disclosure of such information may affect their business / commercial interests, same should not be disclosed without their consent. Therefore, CPIO did not disclose / furnish information to the applicant as per Section 11 and Section 8(1)(d) of the RTI Act 2005. The same was communicated by CPIO to the applicant vide this Ministry's letter dated 28.01.2013 (copy enclosed).

#### Order:

In view of above facts, I do not find that there was any technical error in the decision of CPIO. Therefore, I do not see any merit in the appeal. The appeal is dismissed or merits.

2. Problem faced by sultan Agro Pvt. Ltd Regarding.

This has reference to our various representations of different dates to your office on the above noted Sir, subject. We are very thankful to Mr. Bhopal Singh (Director) & Miss. Suman Dixit (Under secretary) is very cooperative & positive approach in our case.

The Director (K-11) sent our representation to the principal secretary (Home), J&K vide letter no 13012/18/2013-K.V1 dated 12.8.2013 the letter does not pertain to J&K Bank, but to Secretary Agricultural (G.O.I). It is very strange actually the letter pertains to Secretary Agricultural & Cooperative (G.I.O) & should have been forwarded to them instead of sending the same to Principal Secretary Home (JK) which added more trouble to the already harassed promoters & consumption of much needed time. We request you to; please send a copy of the letter to Secretary Agricultural & cooperation at the earliest for their further action.

We have already informed to your office vide letter dated 20.3.2013, JK Bank deceived state vigilance organization , as well as your ministry (G.O.I ), along with documentary evidence of JK Bank, but unfortunately your ministry did not took any serious action against chair man JK Bank. Therefore we approached Honorable Governor (JK) with the request take appropriate action in the matter and copy thereof endorsed to State Vigilance Organization (J&K).

We are glad to inform you that State Vigilance Organization examined our representation on the basis

of our letter dated on 14.06.2013.

And surprisingly, this fact has been confirmed by State Vigilance Organization (GOVT. OF J&K) in their letter no SVO/Bank-G-12/2012-9893 dated: 22/08/2013 addressed to the chairman JK Bank in which SVO has confirmed our allegations leveled by us against the chairman. The above letter also admits that JK Bank has projected wrong facts and deceived before state vigilance Organization as well Ministry of Home Affairs (G.O.I) and other Government Agencies (both central& state) with the intention to harass the promoters. The letter further states the JK Bank has violated RBI Norms & rules & stopped term loan to the company which played a vital role for non-implementation of the project. The above letter of SVO clearly indicates CM' Secretariat by projecting wrong facts. (Copy enclosed- Annexure-A)

There is no doubt now that J&K Bank has been giving tremendous rise to corruption practices in the

state of J&K & the chairman has been playing a major & very important role in its acceleration.

The case was also brought to the office of commissions (CIC) where promoters and SFAC were presen and SFAC become handicapped and could not defend its position stand. It was made clear that there is no sucl guideline in the scheme of VCA, where the promoter has to clear the earlier dose of VCA in order to avail 2<sup>nd</sup>

infusion of VAC as per revised project cost. SFAC was also directed at CIC, to take appropriate decision & consider the request for 2<sup>nd</sup> infusion of VCA based on the norms governing the scheme. (Copy enclosed-Annexure-B)

Recently we are also in receipt of a letter from SFAC vide no; SFAC/6-5/VCA/2007/3305/1921 dated: 08.08.2013 in which they have informed that the J&K Bank has projected wrong facts of the case and has also deceived us. (Copy enclosed- Annexure-C) The SFAC letter further revealed that unit could not received full finance seek from different institution. Also, the bankers revealed that the promoter wanted the change in proposal for up gradation of unit by installation of latest machinery & technology after the project was already sanctioned. We want to make it clear again, that we have never request the JK BANK (CAD )/Branch unit for revising the project, but the fact is that JK Bank of its own decided to make revision and accordingly advised us to get a revised project report prepared & submitted the same to the bank as per directions & the bank wrongly informed SFAC/MFPI the report was submitted to them by the promoter one year later. The SFAC has agreed in their above letter that bank is whole & solely responsible for the delay that grounded the project & has deceived other Govt. Agencies and has play major role in delaying the implementation of the project.

We are glad to inform you that RBI has agreed our point of view & there for (Governor) RBI issued orders to Banking Ombudsman (Delhi office) to re- open our case once again & re-examine the same based on the facts & merits of the case as JK Bank has also deceived Banking Ombudsman by wrong reporting of information. (Copy enclosed-Annexure-D). The State Vigilance Organization JK State also agreed that the chairman JK Bank has deceived various quarters & highest Authority in the country, as well, in the state. (Copy enclosed-Annexure-E)

This fact has also been confirmed by RBI & SVO in their letter & therefore, there is no need for any further evidence in this behalf.

In view of above circumstances of the case, it is proposed that Secretary Agricultural may be advised to desist from any further wrong reporting in our case & SFAC be also directed to provide the enhanced amount of VCA based on approved revised project appraisal of the bank to the promoters so that the project is taken to its logical end and without any further disruption.

We once again most humbly request to you kindly take up the matter with the chief Ministry J&K, with a direction to conduct a High Level Enquire, so that truth &facts are brought to light &justice is provided to the promoters on the base of report of SVO.

M/S Sultan Agro Tech Private Limited has submitted a complaint to his Excellency the Hon'ble Governor J&K Srinagar copy thereof endorsed to State Vigilance Organization wherein inter-alia the complainant has sought redressal of grievances as under:-

- 1) That J&K Bank CAD rejected their term loan proposal time and again by imposing unwarranted and irrelevant pre-disbursement conditions whereas in similarly situated cases no such conditions were imposed by the Bank.
- It was impressed upon Sultan Agro Tech Private Limited to furnish approvals/ commitment letter of MFPI and SFAC Government of India regarding sanction of grant-in-Aid for 310.00 lacs and VCA of Rs.88.90 lacs favouring unit holder.
- 3) The J&K Bank CAD made further modifications for sanctioning of term loan in 2009 and disbursed only 50% of the sanctioned loan however both SFAC/ MFPI did not release grant-in-aid and VCA to the company.
- The J&K Bank in letter dated 14.01.2013 addressed to MOFPI/SFAC, wrongfully mentioned that company has now submitted revised project report whereas, the fact is that the company had submitted report in December, 2010 and hence the bank has misinformed MOFPI/SFAC regarding time of submission of revised project report.
- The Bank took time of 16 months to sanction revised project cost which was sanctioned on 3rd April 2012 for an amount of Rs.1474.14 lacs but again imposed pre-disbursement conditions in sanctioning of Term Loan i.e to furnish the letter of intent/commitment letter from MFPI/SFAC i.e Grant/ VCA in favour of the unit as under:-



Sir,

There is no doubt now that M.O.A (DAC) G.O.I has been giving tremendous rise to corruption practices in SFAC/MFPI and the secretary Agriculture (OAC) & MO (SFAC) & Horticultural Commissioner & Secretary (MFPI) has been playing a major & very important role in its acceleration & surprisingly, the facts has been confirmed by Oirector project/CPIO (SFAC) & Assistance Industrial Adviser/CPIO (MFPI) in their letters. In this connection we are submitting here as under:-

It is now proved that the MFPI has deliberately delayed the implementation of our project by projecting wrong facts and has deceived other Government Agencies (States &Central) & as such no further evidence is required in this behalf;

Regarding Information sought by us under RTI-ACT vide letter dated 3.7.2013; we didn't received any information till date.

There is no such rule that can debar anybody from obtaining any such information from any office. It is obvious that information is not provided to me as <u>I am the father of the Women Entrepreneurs (M/S Sultan Agra Tech (P) LTD)</u> of the proposed venture/ project only for one reason i.e. they will get themselves exposed of their misdeeds & wrong information given to other quarters (in our case) & also the harassment & excesses met by us (due to their lapses) which also led to non-completion of project.

It is also strange that another applicant from the State of J&K has sought same information under RTI-ACT from MFPI, & the information sought for by another applicant was provided by the MFPI vide their no; F.NO. MFPI /RTI 2006 dated 7.8.2013. (Copy enclosed-Annexure-B)

As per letter of MFPI which reads that the RTI-ACT extends to the whole of India except state of J&K UNDER MM-IV. In other words the Ministry is telling that the J&K is no more part of India & is independent. Sir,

M/S Sultan Agro Tech Private Limited has submitted a complaint to his Excellency the Hon'ble Governor J&K Srinagar copy thereof endorsed to State Vigilance Organization wherein inter-alia the complainant has sought redressal of grievances as under:-

- 1) That J&K Bank CAD rejected their term loan proposal time and again by imposing unwarranted and irrelevant pre-disbursement conditions whereas in similarly situated cases no such conditions were imposed by the Bank.
- 2) It was impressed upon Sultan Agro Tech Private Limited to furnish approvals/ commitment letter of MFPI and SFAC Government of India regarding sanction of grant-in-Aid for 310.00 lacs and VCA of Rs.88.90 lacs favouring unit holder.
- 3) The J&K Bank CAD made further modifications for sanctioning of term loan in 2009 and disbursed only 50% of the sanctioned loan however both SFAC/ MFPI did not release grant-in-aid and VCA to the company.
- 4) The J&K Bank in letter dated 14.01.2013 addressed to MOFPI/SFAC, wrongfully mentioned that company has now submitted revised project report whereas, the fact is that the company had submitted report in December, 2010 and hence the bank has misinformed MOFPI/SFAC regarding time of submission of revised project report.
- The Bank took time of 16 months to sanction revised project cost which was sanctioned on 3<sup>rd</sup> April 2012 for an amount of Rs.1474.14 lacs but again imposed pre-disbursement conditions in sanctioning of Term Loan i.e to furnish the letter of intent/commitment letter from MFPI/SFAC i.e Grant/VCA in favour of the unit as under:-

"The disbursement shall be made only after receipt of additional venture capital of Rs.188.76 lacs from Small Farmers Agree Business Consortium (SFAC) & letter of intent from MOFPI" and it has been alleged that this condition has been effected afterthought i.e. after approval from the Chairman.

- 61 It is alleged by the complainant that the whole matter was brought to the notice of Chairman J&K Bank but the grievance of the complainant remained un-attended and unaddressed. The Bank was requested for issuance of letter of credit favouring M/S Alfa Laval India Limited amounting to Rs.219.52 lacs already sanctioned by the bank. However the Bank failed to execute the documents and instead again re-imposed pre-disbursement conditions in the year 2012 with ulterior motives best known to the Bank strangely for construction of Bore Well in the year 2011-12, an amount of Rs.21,97,303.48 was released by the Bank to meet such expenses despite the fact there was no such sanction which smacks of foul play.
- It is also alleged that J&K Bank in the above backdrop has 7) projected wrong facts before Vigilance Organization as well as Ministry of Home Affairs Government of India with sole object to coerce the complainant to confer undue pecuniary benefit upon officers of the Bank. Thus the J&K Bank in violation of RBI norms and rules stopped Term Loan to the Company which played a vital role for non-implementation of the instant project and resulted huge recurring loss to the complainant/ company.

I am directed to request you to kindly look into the whole matter and fact finding report may be furnished to this office at the earliest.
