Sir,

Most respectfully, I have bring into your kind notice that the above said firm has running the illegal business for the manufacturing of guns and cartridges on tempered/ fake/ fabricated licence.

The Bhargav Arms Company has manufactured the illegal Fifty Thousand Guns, Eight Crores 12 Bore Cartridges and Twenty Ton Gun Powder, without explosive licence from 2002 to till date on tempered/ fake licence. The firm has no explosive licence or not any permission to manufacturing of Gun Powder and Lead Shot in the factory premises.

So many times I have complaint to District Magistrate Jammu against above said firm. But District Magistrate Jammu has not take any action against Mr. Amar Bhargav due to he is very rich and influence person and he had paid five lacs rupees to Mr. Kalyan Singh ADC to stop all the proceeding against him to continue their illegal gun factory for the manufacturing of guns and cartridges at Gangyal, Jammu.

It is sorry to point out that the whole recor. particulars the original gun manufacturing register was stolen by Mr. Amar Bhargav from the District Magistrate Office Jammu and the said original register was

tempered by Mr. Amar Bhargav and same register kept with Mr. Satinder Singh Prop. of M/s Sethi Arms Co. Satwari, Jammu. Mr. Amar Bhargav has also tempered the original record of Ministry of Home Affairs, New Delhi with the involvement of some corrupt officers. The copy of the tempered licence is enclosed as Annexure - A B.


Mr. Kalyan Singh Addl. District Magistrate on which ground he has forward the case of all the gun manufacturers to Home Deptt. for issuing of Transport Licence/ Proof Testing permission/ No Objection Certificate without examine the original record and quota of the firms. The owner of the firm Mr. Amar Bhargav asked to all the gun manufacturer that I have pay fifty thousand rupees monthly to Mr. Kalyan Singh ADC for the issuing of above said permission to all the gun manufacturers without examine/ verified the original record.

You are therefore requested to stop the illegal manufacturing activities of the firm and recover the original gun manufacturing register from Mr. Amar Bhargav and take a necessary action under Arms Act.
