
Whereas Shri Kodur Venkatesh had sent an application dated 10.02.2014, seeking information under Right to Information Act, 2005.

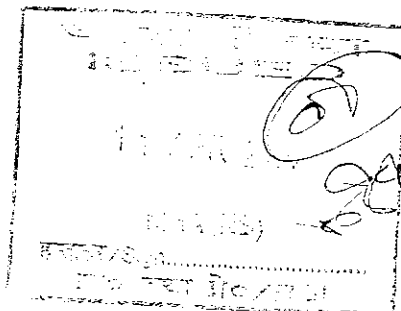

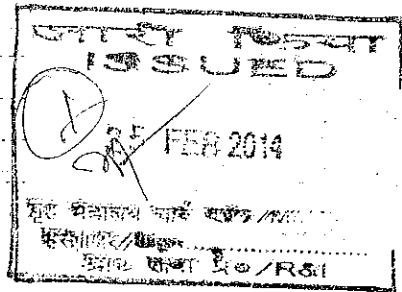

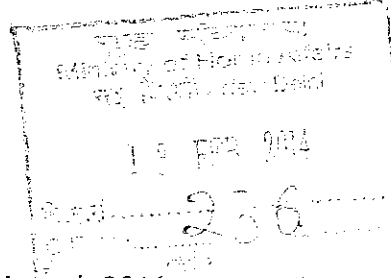
