2. The information as available with the undersigned in respect of point no 2 & 3 of the above mentioned online RTI application is furnished as under :-

2.1 'Under the Security Related Expenditure (SRE) Scheme, the Central Government reimburses to the State Governments of 10 LWE affected States security related expenditure of 106 districts relating to ex-gratia payment to the family of civilian/security forces killed in LWE violence, insurance of police personnel, training and operational needs of security forces, compensation to Left Wing Extremist cadres who surrender in accordance with the surrender and rehabilitation policy of the concerned State Government, community policing, security related infrastructure for village defence committees and publicity material. Detailed list of the 106 districts covered under SRE Scheme is annexed. An amount of Rs 1,391.66 crore has been released by this Ministry to the State Government during the year 1999-2000 to 2014-2015(till date) under the SRE Scheme for LWE affected States for tackling the Maoists'.
