I had filed a petition before the Hon'ble High court of Judicature at madras in Cri.O.P. No 8699/2014 seeking for the direction to the special court for PC Act cases at Chennai to return my passport, which is in the custody of the special court, to enable me to perform "UMRA "pilgrimage.

In the counter filed in the above said Cri. O.P No 8699/ 2014 the department of vigilance and Anti corruption, Tamil Nadu had specified that " It is submitted that the petitioner is figuring as an accused in two cases, Viz, Cr.No 3/12/Ac/CC-I ( Rc37/12/POL/ HQ) & crime no 5/12/ AC/ CC- I ( RC39/12/POL /HQ)".

The said department also stated that "in these two cases, after the completion of investigation, the Government of Tamil Nadu was addressed to get sanction order for prosecuting the petitioner. The Government of Tamil Nadu in turn, had addressed the ministry of Home affairs, Govt. of India to accord sanction under the provisions of prevention of corruption Act, 1998 for prosecuting the petitioner. The sanction order for prosecution is awaited from the Ministry of Home Affairs, Government of India". In the context of the said assertions by the Department of Vigilance and Anti corruption, Tamil Nadu, I kindly request you to furnish the following information under the Right of Information Act, 2005.

The present status of the request for sanction made by the Department of Vigilance and Anti corruption, Tamil Nadu for prosecution in crime No.3/12/AC/CC-i (RC37/12/POL/HQ) & Crime No5/ 12 / AC/ CC- I ( RC39/12/POL/HQ) may be kindly be intimated to me.

I have enclosed a postal order for the value of Rs.10/- bearing no 14F 650060 dated 13.5.2014 in terms of the Right to information Act, 2005.

Since the subject matter involves the judicial proceedings the reply may be given at the earliest.
