2. On perusal of your RTI application, found that you have affixed a court fee stamp of Rs. 10/- on the application which is not a valid application as per Act. As per the guidelines, if application is not accompanied by the prescribed fee of Rs. 10/- or proof of the applicant's belonging to below poverty line, as the case may be, shall not be a valid application under the Act and, therefore, does not entitle the applicant to get the information. Thus, applicant, along with his application, is required to send a demand draft or a banker's cheque or an Indian Postal Order of Rs. 10/- (Rupees ten), payable to the Accounts Officer of the public authority as fee prescribed for seeking information. You can also make payment of fee by way of cash to the Accounts officer of the Public authority or to the Central Assistant Public Information officer against proper receipt. Hence, your original application is returned herewith

3. It is to inform you that you may deposite prescribed fee in terms of provisions contained in sub section (1) (a) of Section 6 of the RTI Act and enable to this Ministry to process your request further.

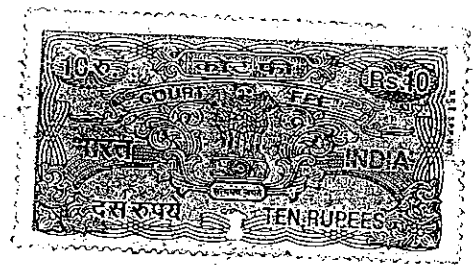
