Sir,

Please refer to your online RTI application's registration No.MHOME/R/2014/61840 dated 10.08.14 (Received in this Section on 19th Aug, 2014).

2. With regard to Point No.1, it is to inform you that, the State Government concerned is required to undertake rescue & relief operation of immediate nature, in all the areas affected by the natural calamity including floods. As per the Scheme of State Disaster Relief Fund (SDRF)/erstwhile Calamity Relief Fund (CRF), the State Level Committee headed by the Chief Secretary has been empowered to operate these funds. No calamity-wise/district-wise allocation of fund is made to the State. Like-wise, allocation in the SDRF of the State is made for the entire State for all notified calamities, and it is for the State Government concerned to allocate the funds from SDRF to various districts through concerned district authority, in the wake of a natural calamity including flood, in accordance with the magnitude of the ground situation and also to undertake relief operation in all the areas affected by the natural disaster including flood, drought etc.

3. However, the year-wise allocation and releases of funds to the State Government of Assam from State Disaster Response Fund (SDRF) and National Disaster Response Fund (NDRF)/National Calamity Contingency Fund (NCCF) during the years 2005-06 to 2014-15 is given as under:-
