Sub: Information sought under the RTI Act, 2005 vide your application dated NIL.

Please refer to this Ministry's letter No. 23014/24/2012-VS dated 8th April, 2013 in connection with your application dated NIL under the RTI Act, 2005.

2. Available information on point no. 3 of the above said application is furnished as under:-

2.1 'Police' and 'Public Order' are State subjects and action with respect to maintenance of law and order primarily lies in the domain of the State Governments concerned, who deal with the various issues related to Left Wing Extremist (LWE) activities in the States. The Central Government closely monitors the situation and supplements the efforts of the State Governments over a wide range of measures. The Central Government assists the State Governments through security and development related Schemes. In security related interventions, apart from directly deploying Central Armed Police Forces (CAPFs), the Government of India provides assistance for capacity building of the States through Schemes like the Security Related Expenditure (SRE) Scheme, the Special Infrastructure Scheme (SIS), the Construction/ Strengthening of Fortified Police Stations Scheme, etc. On the development front, the Central Government is implementing Special Schemes for LWE affected areas like the Integrated Action Programme (IAP), the Road Requirement Plan-I etc.

2.2 Based on violence profile, presently 106 districts in 9 LWE affected States are covered under the Security Related Expenditure (SRE) Scheme, for the purpose of reimbursement of expenditure incurred by the State Governments on Anti-Naxal Operations. The list of such districts is annexed.

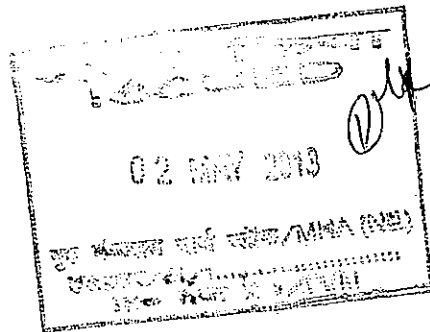

This is regarding your RTI application dated Nil under the RTI Act, 2005 received on transfer on 31.01.2013.

2. In this regard, it is stated that except for point No.(16), none of your queries relate to this Unit. The subject matter of your queries [other than point No.(16)] may be related to HR, J&K, IS-I, P-I, P-II, UT, DM, and NM Divisions of MHA, DOP&T, Ministry of HRD, Ministry of Petroleum and Natural Gas, Indraprastha Gas Limited and Delhi Police. In view of the above, a copy of your RTI application is being forwarded to these offices for providing information available with them, to you directly. You are requested to contact the CPIOs concerned for further information in this regard.

3. So far as point No.(16), regarding SPG and NSG Security provided to individuals is concerned, it is stated that security by SPG is provided in terms of provisions of SPG Act, 1988. NSG security cover to an individual is provided only on the basis of comprehensive threat assessment made by the Central Security Agencies. Details of individuals provided with security cover are exempted under Sections 8(1)(g) and 24(1) of the RTI Act-2005. However, a copy of your above-mentioned RTI application is being forwarded to SPG and NSG, for providing information, if any, directly to you.
