

2	How many employees of these Forces have opted for VRS?	Total employees of CAPFs proceeded on VRS from 1.1.2013 to 30.6.2013= 3156 given the total size/strength the CAPFs of around 8.5 lakh, the number of VRS cases can not be said to be huge.
7	What steps are being taken for stopping the huge exodus of the jawans by way of VRS?	
3	Why is the number of optees for VRS highest from the BSF?	In this regard, it is informed, that, reply to queries such as 'explain' 'specify' does not fall under the ambit of RTI, Act, 2005. Therefore, it is not possible to furnish any information on this point.



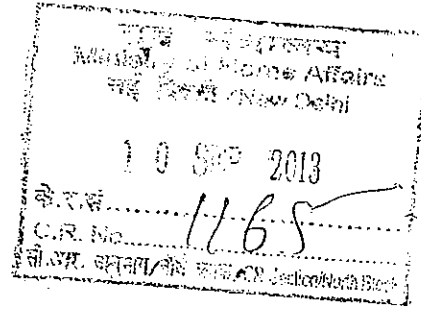
