Office Memorandum

As the information sought by Shri Simranjit Singh Mann vide his application dated 9th June, 2011 under RTI Act (copy enclosed) was not available in UT Division, the said application was transferred to IS Division of MHA and Delhi Police for taking appropriate action. On subsequent Interim Order passed by CIC dated 12/12/2013, all relevant documents available in the custody of UT Division regarding SIT constituted to investigate the case relating to the assassination of late Prime Minister, Smt. Indira Gandhi and the role of three accused S/Shri Satwant Singh, Beant Singh and Kehar Singh were gone through. However, no report of the SIT is available on record. During the hearing of CIC on 25th March, 2014, the Hon'ble CIC ordered that relevant information available in the records of whole of MHA should be brought before the CIC in its next hearing.

It is, therefore, requested that information/documents relating to the information sought in the above RTI application and SIT investigation in to the case available in the records of MHA may kindly be provided to the undersigned for placing it before the CIC in its next hearing positively by 4th April, 2014. If no information is received from any of the Divisions, it will be assumed that no information is available and CIC will be informed accordingly. This may be accorded **TOP PRIORITY**.


