(I), (II) and (III) of the said RTI application of Shri Fagesh Kumar Sahu is by and large in accordance with the facts and records available with him. However, information sought vide point nos. (I), (II), (III) and (IV) of the said RTI application dated 30.5.2013 is once again furnished in the attached Annexure with minor modifications for more clarity.

3. That, the Appeal Petition is hereby disposed of accordingly.
