


- 2. Available information as sought vide the above said application is furnished as under:
 - 2.1 'Police' and 'Public Order' are State subjects and action with respect to maintenance of law and order primarily lies in the domain of the State Governments concerned, who deal with the various issues related to Left Wing Extremist (LWE) activities in the States. The Central Government closely monitors the situation and supplements the efforts of the State Governments over a wide range of security and development related measures, inter-alia, including reimbursement of expenditure incurred by the State Governments on Anti-Naxal Operations under the Security Related Expenditure (SRE) Scheme. During the last 5 years (from 2008-09 to 2012-13), an amount of Rs 807.20 crore has been released to the 9 LWE affected States viz. Andhra Pradesh, Bihar, Chhattisgarh, Jharkhand, Madhya Pradesh, Maharashtra, Odisha, Uttar Pradesh and West Bengal under the SRE Scheme.
 - 2.2 Helicopters are also made available for use as per operational requirements in the LWE affected States. The availability of Helicopters acts as an important force multiplier and Helicopters are extremely useful to the Security Forces in casualty evacuation and movement of reinforcement in times of need.
- 3. Appeal u/s 19(1) of the Act, if any, is to be made within 30 days of receipt of this communication and the same in respect of this information lies with Shri M.A. Ganapathy, Joint Secretary, Naxal Management Division, Room No. 193-A/1, North Block, New Delhi 110 001.
