Please refer to this Ministry's letter No. I-11034/31/2013-NM/ANO-I dated 8th August, 2013 in connection with your application dated 11.07.2013 under the RTI Act. 2005.

- 2. Available information as sought vide point nos. (4) and (5) of the above said application is furnished as under:
  - 'Police' and 'Public Order' are State subjects and action with respect to 2.1 maintenance of law and order primarily lies in the domain of the State Governments concerned, who deal with the various issues related to Left Wing Extremist (LWE) activities in the States. The Central Government closely monitors the situation and supplements the efforts of the State Governments over a wide range of security and development related measures including reimbursement of expenditure incurred by the State Governments on Anti-Naxal Operations under the Security Related Expenditure (SRE) Scheme. So far, since its inception in 1996, a sum of Rs 1186.56 crore has been released to the 9 LWE affected States of Andhra Pradesh, Bihar, Chhattisgarh, Jharkhand, Madhya Pradesh, Maharashtra, Odisha, Uttar Pradesh and West Bengal under the SRE Scheme.
  - Under the SRE Scheme, the Central Government, inter-alia, reimburses to the State Governments the ex-gratia payment of up to Rs. 1 lakh to the family of civilian killed and Rs. 3 lakh to the family of security personnel killed in LWE violence.
- Appeal u/s 19(1) of the Act, if any, is to be made within 30 days of receipt of this communication and the same in respect of this information lies with Shri M.A. Ganapathy, Joint Secretary, Naxal Management Division, Room No. 193-A/1, North Block, New Delhi -110001.
