



Sheep, goats are being shifted towards Jammu and Kashmir under Indian Army supply cover and these animals are being shifted in goods transport vehicles in double decker position, overcrowded as well, please supply me the copies of circular and orders passed about these animals for their welfare and to minimize unnecessary pain and sufferings.

Complete list of camels shifted towards Delhi from Rajasthan by the Border Security Forces, to take part in Republic Day parades, type of vehicles along with the camels shifted in each vehicles, position of camels during their shifting in vehicles, whether in sitting or standing position along with the time consuming during traveling.
