2. As regards your queries, it is informed that no consolidated record of complaints received for disrespect of Indian National Flag is maintained in this Ministry. The complaint regarding disrespect/insult to the National Flag by any individual/organization is made at the nearest police station. The police authorities, who are charged with enforcement of law and order in their respective territorial jurisdiction, are responsible for taking action under the law for violation of the provisions contained in the Prevention of Insults to National Honour Act, 1971 and Flag Code of India, 2002. This information is scattered among various State/UT Administrations. You may approach them directly for getting the information. This Ministry from time-to-time issues advisories to all State Governments/UT Administrations, Ministries/Departments of Government of India to ensure the strict compliance of the abovesaid Act.

3. Appeal, if any, may be made under Section 19 (1) of the Right to Information Act to the Appellate Authority within 30 days. The particulars of Appellate Authority are as under:-
