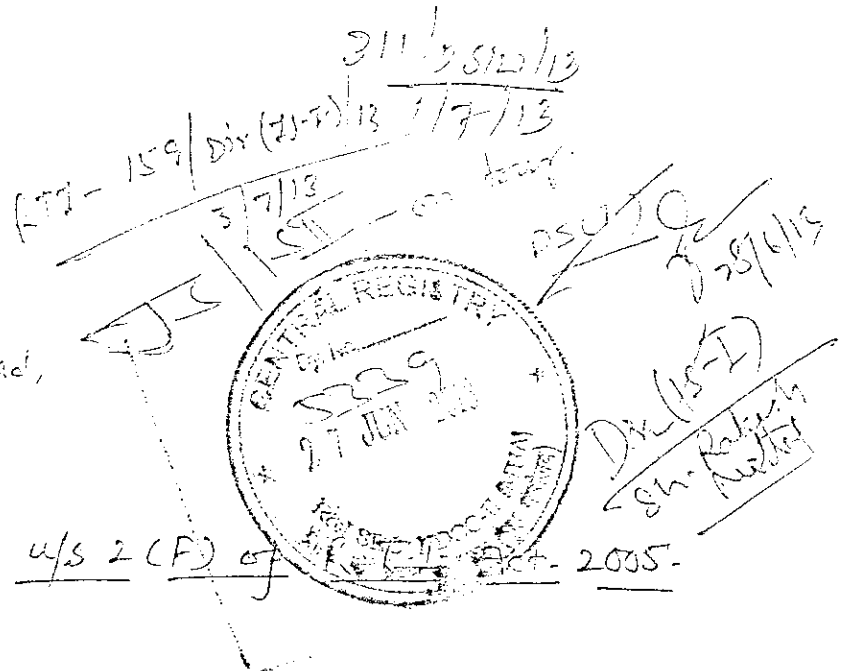

Kindly inform, does the C.B.I. allow to tape down the no. of anyone for without the prior permission of this office?

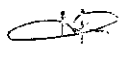
