Prayer or Relief Sought :	<p>The applicant is an octogenarian senior citizen and seeks information based on following points and also requests for providing the information immediately and my proof of age is enclosed: 1.What would be the pension of a person revised from time to time with effect from 01.01.1989 to as on today if his basic pay scale as on 31.12.1988 was Rs.950-1500/- and his basic pay was Rs.1300/- and the person retired on 31.12.1988 and qualifying service was: Case I. 10 Years Case II. 20 Years Case III 30 Years, enclose evidence in support of reply. 2.What would be the total salary of a person as on 31.12.1988 if his basic pay scale was Rs. 950-1500/- and his basic payment was Rs.1300, enclose evidence in support of reply. Where an application/request has to be filled for carrying out threat assessment to be done by security agencies of an individual who has served VVIPs and was barely in proximity of 20 Meters from such VVIPs, enclose evidence in support of reply. After threat analysis of an individual who has served VVIPs, if it is found that the individual needs security/protection, then who will provide the same and the security/protection to the individual will be given automatically or the individual has to file a request/application to any authority, if so then to whom, enclose evidence in support of reply. The reply of CPID contained information related to point 01 of original application but that too incomplete as the information was sought as in accordance with 4th CPC along with 5th CPC and 6th CPC but the reply related to 4th CPC did not come and no reply was given in respect to points 02, 03 and 04. What the applicant suppose is that point 02, 03, 04 were supposed to be transferred to MHA hence in view of above information stands to furnished hardly 20%.</p>
