
**OFFICE MEMORANDUM**



Sir,

Please refer to your RTI application dated 12.06.2014 received in this unit on transfer on 27.06.2014 for providing information on Point Nos. (1), (2) and (3) of your application.

2. As regards point No. (1) and (2) of your application, it is stated that as regards expenditure incurred on swearing in ceremony including expenditure on security arrangements is concerned, this unit has no information to furnish and the same may be treated as 'Nil'. However, a copy of your application is being transferred under Section 6(3) of the RTI Act-2005 to CPIO, Cabinet Sect., Ministry of Urban Development, Ministry of Defence, Delhi Police, CS Division, P-II Division and Public Section of MHA for providing information directly to you.


3. As regards point No.(3) of your application, it is stated that security to an individual is provided on the basis of threat assessment carried out by the security agencies or threat attached to the position held by them under the Government. Details in this regard are exempted under Section 24(1) of the RTI Act-2005. Regarding expenditure incurred on security, it is stated that providing security to an individual is primarily the responsibility of the state government concerned, in whose jurisdiction such individual is ordinarily resident or happens to be. Due to the involvement of multiple agencies, including state government agencies, it is difficult to calculate the actual expenditure incurred on providing security cover and such details are not maintained in this office.


