

As per the instructions of Govt. of India, the personnel of CRPF posted in Jagdalpur (Distt: Bastar, Chhattisgarh) are entitled for Risk area allowance. Accordingly, since CRPF Battalions such as 80 Bn, 151 Bn, 4 Singal Bn etc. deployed in Jagdalpur, the personnel posted in these Battalions are drawing Risk allowance. But, even though the Office of DIGP, CRPF, is located at Jagdalpur, staff posted in DIGP Office, CRPF, Jagdalpur are not authorized to draw Risk allowance, with the reason that, DIGP Office, CRPF, Jagdalpur is a static office.

12) It is to mentioned here the following points:-

- It is a known fact that, the staff of DIGP Office, CRPF, staying in Jagdalpur are equally prone to risk of life, that would be confronted by personnel of said Units of CRPF deployed in Jagdalpur.
- The risk of Naxals perhaps, may not spare the personnel of DIGP Office, CRPF, because they are posted in a Static Office and the risk of naxals perhaps, may not lie only the personnel posted in said Battalions of CRPF, deployed in Jagdalpur.
- > The personnel of same Force (CRPF), staying/deployed in the same place, but, some are authorized for Risk allowance and some are not.
- 03) Under the RTI Act, 2005, it is requested to kindly intimate me the rule position whether the Risk Allowance is authorized by Govt. of India, for all the CRPF personnel posted in Jagdalpur, Distt: Bastar (Chhattisgarh) or otherwise. Required fee of Rs.10/- in the form of IPO bearing No. 22F-796855 dated 23/5/14, is enclosed herewith.
