

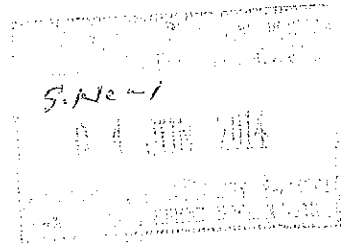

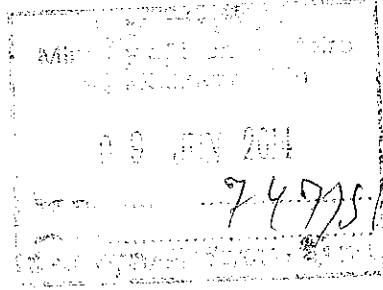

I am directed to refer to your RTI applications dated 21.4.2014 received in this office on 05.5.2014 on the above mentioned subject and to say that the reservation for SC/ ST/ OBC/ ExS/etc. categories is available as per extant Govt. Orders and as communicated by the departments reporting vacancies. Vacancies for Ex.Servicemen are reserved only for Group 'C' posts and not for Group 'B' posts as per extant Government orders/instructions. The post of Sub-Inspector in CAPFs carries pay scale of Rs 9300-34800 in Pay Band 2 with Grade Pay of Rs 4200 and is classified as Group 'B' Non-Gazetted, Non-Ministerial as per letter No.1-45023/4/2010-Pers.II dated 29<sup>th</sup> March 2011 from Ministry of Home Affairs.

If you are not satisfied with the information furnished above, you may prefer an appeal to Sh. Manab Ray, Dy. Secretary & Appellate Authority, SSC, Block No.12, CGO Complex, Lodhi Road, New Delhi.

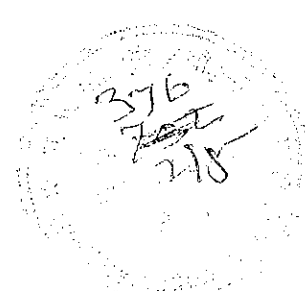

Sub: Request to Know about the implementation of reservation policy for Ex-servicemen, under RTI Act 2005.

Sir,

With due respect I lay down the following few lines for your kind consideration please.

Ref. Gazette of India: Extraordinary Part II-Sec 3 (i) dt 04 Oct 2012, File No. 36334/1/2006-Estt. (Res.) Signed by Mr. Manoj Joshi, Jt. Secy. to the Govt of India.

As per the above mentioned Gazette, Ex-servicemen are eligible to get Ten Percent reservation in the Recruitment of Sub Inspectors in all Para-military, because sub inspector in Para-military is lower rank than an Assistant Commandant.

As Staff Selection Commission issued notice for Recruitment of Sub Inspectors in BSF/CISF/CRPF/ITBPF/SSB through "RECRUITMENT OF SUB-INSPECTORS IN DELHI POLICE, CAPFs AND ASSISTANT SUB-INSPECTOR IN CISF AND INTELLIGENCE OFFICER IN NCB EXAMINATION, 2013" on 16 Mar 2013. SSC did not mention the reserved seat in Sub Inspectors for Ex-servicemen in Notification.

As per the Gazette of India: Extraordinary dt 04 Oct 2012, Ex-servicemen are eligible to get 167 seats of Sub Inspectors that is Ten Percent of 1670 (Total seat of Sub Inspectors in CRPFs in the above said Recruitment), and in particular as below:-

- Sub-Inspector in BSF - 45 (10% of 446)
- Sub-Inspector in CISF - 81 (10% of 808)
- Sub-Inspector in CRPF - 21 (10% of 212)
- Sub-inspector in ITBPF - 14 (10% of 136)
- Sub-Inspector in SSB - 07 (10% of 68)

Staff Selection Commission declared final result of the above said Recruitment on 15 Apr 2014. But SSC did not give any seat in the Rank of Sub Inspector to Ex-servicemen as reserved, **which is injustice with Ex-servicemen.**

I wish to know that why SSC not followed the Gazette of India: Extraordinary dt 04 Oct 2012, which was published five month before the publication of Notice for RECRUITMENT
