

1.	Who comes under the definition of martyr & under which conditions the status of martyr is given to the individuals?	It is informed that Shaheed/Martyr is not defined by the Government anywhere and presently neither such order/notification are being issued to grant status of Shaheed/Martyr to those Central Armed Police Force (CAPFs i.e. BSF, CRPF, CISF, ITBP & SSB) personnel who are killed in action while discharging their duty. However, their families/Next of Kin (NOKs) are given full family pension under the Liberalized Pensionary Award (LPA) rules i.e. the last pay drawn, and ex-gratia compensation as per rules in addition to the other benefits admissible.
2.	Whether the above status is given to the person of serving in Army, Air Force and Navy or also given to the persons working in ITBP, CRPF, BSF, CISF and other armed forces.	
3.	Whether the benefit of martyr status is also given to the persons sacrificed their lives in armed forces. If no benefit is being given to the persons of armed forces then why it is not being given. Please inform with detail.	
4.	What is the mode of awarding the status of martyr i.e. by awarding the certificate, letter of gazette notification or any other mode? Please give details on the above subject.
