
Reference your online RTI application registration number **PMOIN/R/2014/60896 dated 03/08/2014**, seeking information under RTI Act, 2005.

2. The requisite information is as under:

Sr.	Point	Reply
(i)	Govt. of India has also extended the job reservation/age relaxation in appointments to the Central Government jobs. The Govt. of India had decided to give ex-servicemen status to the retired personnel of the Central Paramilitary Force in November-2012. How many States have extended the facility to the Paramilitary personnel at par with the Ex-Servicemen of Armed Forces of the Union.	As per MHA OM No. 27011/100/2012-R&W dated 23/11/2012, retired Central Armed Police Forces personnel from CRPF, BSF, CISF, ITBP and SSB are declared as " <u>Ex-CAPF personnel</u> " and not " <u>Ex-Servicemen</u> ". In the aforesaid OM, it has been inter-alia mentioned that State/UT Governments concerned may extend suitable benefits to Ex-CAPF personnel on the line of Defence Forces. The State/UT Governments are at liberty to extend benefits to Ex-CAPF personnel at par with Ex-Servicemen of Defence Forces personnel. However, as on date Goa (State), Daman & Diu and Dadar & Nagar Haveli have issued notification to extend the benefits as available to the Ex-Servicemen to all retired Central Armed Police Force Personnel (Ex-CAPF personnel) of their States.
(ii)	Whether the Govt. of India has also extended the facility of job reservation/age relaxations in appointments to the Central Govt. services.	No.


