
Sir,

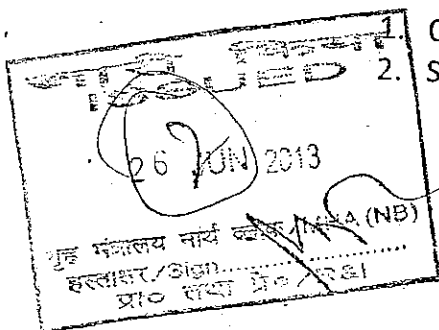

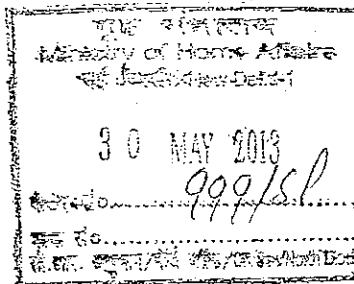
