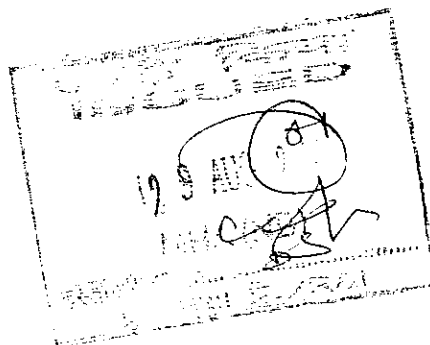

Please refer to your RTI application dated 05.07.2014 received in this unit on transfer on 12.08.2014.

- In this regard, it is stated that Point Nos.(1) to (4) of your application do not relate to this unit. Term VIP/VVIP is not part of any official nomenclature and this unit is not aware of any norm/criteria for categorization of an individual as a VIP/VVIP. This Unit only deals with categorization of individuals for the purpose of provision of security based on assessment of threat carried out in consultation with security agencies.
- However a copy of your application is being transferred under Section 6(3) of the RTI Act-2005 to CPIOs, Public Section, MHA and CS Division, MHA for providing information if any, that they may have on the subject, directly to you.
- Regarding point No.(5), it is stated that security is provided by the Government to individuals based on assessment of threat carried out in consultation with security agencies in 4 categories, namely, 'X', 'Y', 'Z' and 'Z+'. Further details in this regard are exempted under Section 24(1) of the RTI Act-2005 and cannot be disclosed.

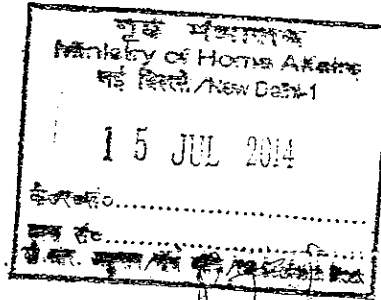


