

2. Shri. Nathuram Godse and Shri. Narayan Apte (Convictor's in the Murder of Mahatma Gandhiji) was executed to death on November 15, 1949 at Ambala Jail. In this connection, Please provide the documents of the execution that has been carried out in the Jail and any document available on record on that day.
3. That the Narayan Apte has written a Thesis during his time in Jail as a prisoner named "Administrative set up" or some document or letter or book or some article. As per his wish, this has been transmitted to the Government of India by the Jail Superintendent after his execution. In this connection, provide the Thesis or document or letter or book or article that has written by him and which has been transmitted to Govt. of India by Jail Superintendent. Also, provide any documents, records which Jail Superintendent has sent to Govt. of India in this regard.
4. Please provide the documents records pertaining to execution of convictors of Mahatma Gandhiji murder.
5. Please provide entire records documents and any other information pertaining to murder trial of Mahtama Gandhiji held or preserved by Govt. of India.

Provide all the documents in form of certified copies.
