

It is again reiterated that the Ashoka Chakra Series of Gallantry Awards is dealt with by the Ministry of Defence. The role of MHA is restricted to recommending the cases of Civilians/Police Personnel and Member of Para Military Forces for these awards to Ministry of Defence. The Awards are declared and the notifications are issued by the Ministry of Defence. No separate list of the awardees of the Defence personnel and Non defence personnel are maintained by this Ministry.

3. Appeal if any, may be made under Section 19(1) of the RTI Act to Shri Satpal Chouhan, Joint Secretary (Admn), Room No. 194, Ministry of Home Affairs, North Block, New Delhi-110001, the Appellate Authority, within 30 days.


1. Kindly provide me with following information under RTI Act, 2005

 - (c) How many Ashoka Chakra and Kirti Chakra have been awarded to members of Indian Air Force, Indian Navy, Para military forces and Police Force (please give only numbers against each Force)
 - (d) How many Sena Medal (Gallantry) have been awarded posthumously (please give only number).

2. Kindly note that this information [Para 1 (a), (b) & (c)] was asked to Ministry of Home Affairs (MHA) and they have confirmed that Chakra series awards are given by Ministry of Defence (MoD) and in case of Police & Para military personnel and civilians these awards are given by MoD based on recommendation of MHA.

3. Ministry of Home Affairs has put up all information about honours and awards in their website www.mha, however same is not done in MoD which is mandatory requirement under section 4 of RTI Act, 2005. Kindly post full information in MoD website also.
