





The applicant is seeking following information:


1. What policy decision has been taken by the UOI in compliance of orders dated 01.06.1984, 26.08.2010, 06.10.2010, and 12.01.2011 passed by the Hon'ble High Court of Delhi in Writ Petition (Civil) No.1512 of 1984 titled as Indraprastha Vishva Hindu Parishad Versus Union of India & Ors.

Please provide the copy of entire file wherein said policy decision was taken.

2. Please provide the copy of entire file wherein Notification No.S.O.661(E) dated 5th March, 2014 published in the Gazette of India Extraordinary Part-II on 05.03.2014 was issued by MINISTRY OF HOME AFFAIRS under Section 93 of THE RIGHT TO FAIR COMPENSATION AND TRANSPARENCY IN LAND ACQUISITION, REHABILITATION AND RESETTLEMENT ACT, 2013 and Government of India has withdrawn from the acquisition the properties mentioned in said notification under the control of Land and Development Office and Delhi Development Authority.
