Please refer to your RTI application dated 09.06.2014. The point-wise requisite information are given as under:


- (1)&(2). There is no RA Scheme in existence for providing jobs to the children of the deceased employees.

That my late father R.Venkata Rao appointed and joined in the erstwhile DMK Project, Koraput in the Dist. of Koraput, Orissa on 1-10-1960 in the Office of the Dy.Chief Administrator, DMK Project. and died while in service on 29-1-1989 as U.D.Clerk. (Copy of the death certificate is enclosed herewith) ...
2. My deceased father was appointed by the Central Govt. under the control of Ministry of Home Affairs and he has served as a Central Govt. servant for a period of 28 years. ...
3. As soon as my father died on 29-1-1989 I being the son of my late father has applied for a job under the Rehabilitation Assistance Scheme on 10-2-89 under Group " D " Post (Copy enclosed) to the Zonal Administrator Dandekaranya Dev. Authority Koraput. ...
4. The Zonal Administrator, D.D.A Koraput in his official letter No.52/16/87 A-II dt. 15-2-1989 (Copy enclosed) has informed me that my case is under consideration and the appointment Order as prayed for will be issued within due course. ...
5. No appointment order has been issued to me. But the Zonal Administrator DDA Koraput in his letter No.52/16/87/ A-II dt. 20-2-1989 (Copy enclosed) has referred the matter to the Under Secty. to Govt, Ministry of Home Affairs (Rehabilitation Division) New-Delhi and stated therein that this DMK Project has been winded up and my case for appointment as Class IV post in any central Govt. Offices may be considered and orders to that effect may be issued as per G.O.NO.14014/6/86 Estt. (D) Dt. 30-6-1987 of Govt. of India Ministry of Personnel and Public Grievances and Pension Deptt of Personnel and Training. ...
6. I am a Scheduled Caste person (Copy of caste certificate is enclosed) ...
7. My mother R.Jagadamba is getting family pension till today as per authority No. FA/Pen/P.P.C NO.258/72-74 dt.14-4-1989 (Copy enclosed) of the Pay & Accounts Officer (Pension) DMK Project, Koraput. ...

8. Sri Surjit Singh Under Secty (R) in his letter No. dated 2-3-1998 has referred the matter to the Director General, Deptt. of Telcom Sanchar Bhawan-20 Ashoka Road, New Delhi for my appointment. ...  
( Copy enclosed) Since Telcom is not the appointing authority of my deceased father they have remained silent over the matter.
9. Sri Moti Lal, Section Officer (RIS/MD) in his letter NO.14/3/2010-RIS/MD Ministry of Home Affairs (FFR Division Rehabilitation Wing Jaisalmer House Mansingh Road New-Delhi dt.3-8-2010 (Copy enclosed) has referred the matter with the Secretary, Govt. of Orissa H & U.D. Deptt, Bhubaneswar to take appropriate action on my case. But he has not carried the request of Moti Lal with a view that my deceased father has never worked under Orissa State Govt. ...
10. Sri S.K. Parida Under Secty. to Govt. of India in his letter No.14/3/2010/RHD/MD Ministry of Home Affairs dt.3-1-2011 (Copy enclosed) has also referred the matter with the Secretary, Govt. of Orissa H & U D Deptt. Bhubaneswar for consideration of my case. But he has not taken any action with a view that my deceased father has never worked under Orissa State Govt. ...
11. The Joint Secty. to Govt. H & U D Deptt, Orissa Bhubaneswar in his letter No.6425 dt.4-3-11 (Copy enclosed) has intimated me that my mother is getting family pension from Ministry of Home Affairs, Govt. of India and as Govt. of India, Ministry of Home Affairs can consider my appointment under R.A. Scheme. This is the correct fact what the Joint Secretary says. When my deceased father worked under Central Govt. why other Deptts other than Home Affairs can take action in the matter. ...

Now the following information is required by me which may please be supplied under R.T.I. Act.

1. My deceased father worked under Central Govt. and died while in service. Although I applied for a job under R.A. Scheme, why the Central Govt. Home Affairs Rehabilitation Division has not appointed as yet and why the said Deptt. always referring the matter to other Deptts. who are not the authority for my appointment.

2. Since my deceased father worked under the control of Home Affairs Deptt. Govt. of India Central Govt. why that Deptt. has not appointed me for the post which I have applied for under R.A. Scheme.

3. The reasons for which my case has been referred to Orissa Govt. may pleased be stated as they are not the appointing authority and also my deceased father never worked under Orissa State Govt.

4. I want reasons as to whether the Home Affairs Deptt can issue appointment order to me or not, if not the reasons shall be reported.

5. I want the xerox copy of the entries of the Service Book of my deceased father from the date of joining and till his death.
