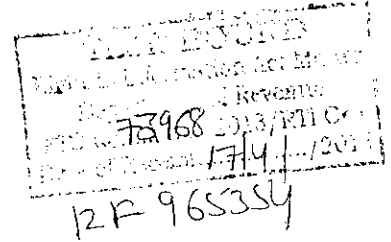
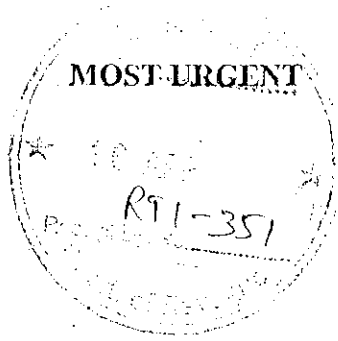

They have decided to have children through **surrogacy in India only**.

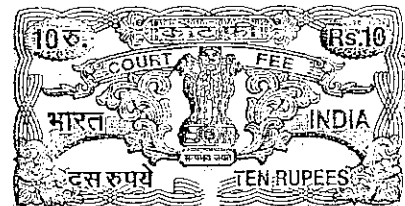

1. Documents and their formats required to bring embryos from USA to India.
2. Documents and their formats required for child/children born due to Surrogacy in India, to obtain Birth certificate (at place of Birth) in India.
3. Documents and their formats required for child/children born due to Surrogacy in India, to obtain passport from Hyderabad only.
4. Is it required for both my son and daughter-in-law to be physically present in India, when embryos are brought to India.
5. Documents and their formats required while importing embryos to India.
6. Does your department have any registered or authorized agency to transport embryos from USA to India? If yes, please provide their Postal addresses, e-mails and telephone numbers. If not, please confirm that you do not have any authorized agents.
7. Please let us know any other legal compliances which we are required to execute prior to, during Surrogacy and Post birth of child/children.

2. The information sought in the RTI application is not maintained in the Ministry of Home Affairs, (Foreigners Division). Ministry of Home Affairs (Foreigners Division) has issued instructions with regard to the type of visa applicable to foreign nationals coming for commissioning surrogacy in India and the conditions to be fulfilled in this regard. These instructions are also available on the website of Ministry of Home Affairs www.mha.nic.in-Citizens Services-Foreigners Division. Since the issues raised in the RTI application are closely connected to the functioning of Ministry of Health and Family Welfare, the RTI application is transferred to the Ministry of Health and Family Welfare under Section 6 (3) (ii) of the RTI Act, 2005, with a request to furnish the requisite information directly to the applicant within the prescribed time limit.

3. A similar RTI was also transferred to you vide this Ministry's letter of even number dated 29.04.2013.

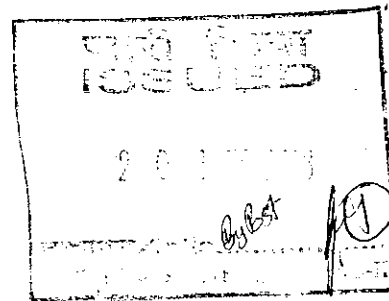
