

ORDER

Subject: - First Appeal under the RTI Act, 2005 filed by Shri Gopi Ram G.

Whereas Shri Gopi Ram G, vide his application dated 10/6/2014 (received in this Ministry on 18/6/2014) had sought information from the Ministry of Home Affairs under the RTI Act, 2005.

2. Whereas as per RTI Act, 2005 and Right to Information (Regulation of Fee & Cost) Rules, a request for obtaining information under sub section (1) of section 6 of RTI Act, 2005, shall be accompanied by an application fee of Rupees Ten either by way of cash against proper receipt or by Demand Draft or Bankers Cheque or Indian Postal Order payable to the Accounts Officer of the Public Authority from where information is sought.
3. Whereas the applicant have not remitted the application fee along with his above mentioned application, the CPIO vide his letter dated 27.6.2014 returned his communication. He was also informed that the contents of his application are not legible and it is not clear the details of information he required from this Ministry. The appellant has not resubmitted any application further with the mandatory fee and now preferred for an appeal dated 13.7.2014 (received in this office on 17.7.2014) which is also not legible.
4. Whereas Shri Gopi Ram G has not submitted any RTI application further with fee in proper order. filing of 1st appeal does not arise. The communication of the applicant is accordingly disposed of.

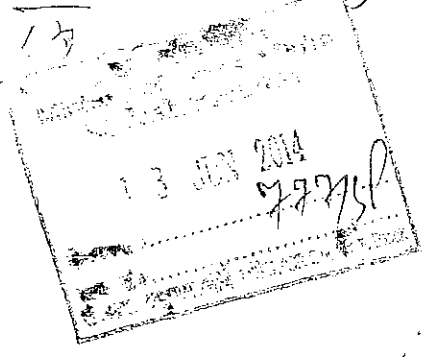

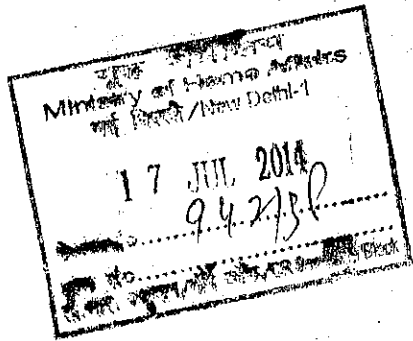
