

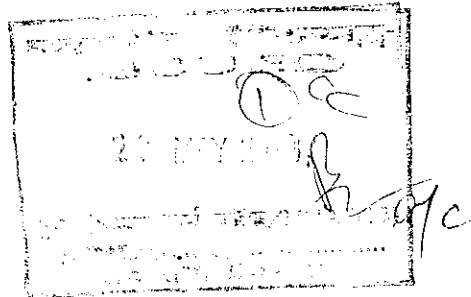
Subject: Information sought under the RTI Act, 2005 by Shri A.K. Goyal.
