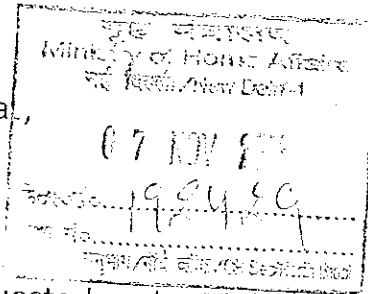

Sub: Information Requested under Right to Information

The following information is requested from your office vide right to information:

The PSAR Act 2005 states that: (2) A company, firm or an association of persons shall not be considered for issue of a licence under this Act, if, it is not registered in India, or having a proprietor or a majority shareholder, partner or director, who is not a citizen of India.


It is observed that a few private security companies such as Group 4 Securicor and Pinkerton are functioning in India despite the fact that these companies are not majority owned by Indian nationals and above the limit of 49% foreign investment permissible for private security companies.

It is further observed that such security companies have also obtained PAR licenses in various states of India despite not being eligible to do business in India as per the PSAR act 2005.

Can you please explain how and why these private security companies have been granted PSAR licenses in most states of India when there is no provision for such companies to obtain licenses by such companies as defined in the PSAR Act 2005?
